82ND ANNUAL MEMBERSHIP MEETING OF BLUEBONNET ELECTRIC COOPERATIVE, INC.

May 10, 2022

The Annual Membership Meeting of Bluebonnet Electric Cooperative, Inc. was held on Tuesday, May 10, 2022, at 1:30 p.m. at The Silos on 77, Giddings, Texas, with Members invited for registration via a drive-through event, and Board Members and Executive Staff conducting an in-person meeting inside The Silos facilities without Members present in compliance with the Cooperative's Bylaws and for public safety and health during the continuing COVID-19 pandemic.

General Counsel Sarah E. Newman-Altamirano certified that 6,113 proxies were registered with the Cooperative of which 5,235 were assigned to the Proxy Committee, 861 were assigned to a Director of Bluebonnet Electric Cooperative, Inc., one (1) was assigned to a Bluebonnet employee present at the meeting, and 16 were assigned to other Members.

President Ben Flencher, presiding as Chairman, called the meeting to order at 1:30 p.m. and the Lord's Prayer was prayed in unison.

Chairman Flencher opened by noting that this year's Annual Meeting is being held similarly to the previous Annual Meeting of the Membership in the interest of protecting Bluebonnet members, directors and employees during the continuing COVID-19 pandemic.

Chairman Flencher congratulated Milton Shaw and Debbi Goertz on their re-election and his pleasure of being re-elected to the Board. He then discussed procedures for the proxy process and Bluebonnet's successes over the past year.

Secretary-Treasurer Robert Mikeska certified that the Annual Meeting Notice was published in the May 2022 issue of the Texas Co-op Power and mailed to all members on April 27, 2022, giving notice of the drive-through event for the safety and health of Bluebonnet's members and employees during the continuing COVID-19 pandemic; the total number of members on the date of the Annual Meeting was 88,554, the total number of non-member consumers on the date of the Annual Meeting was none, there were 6,113 members in attendance by proxy, which number constitutes a quorum, and thereby officially opens this meeting to transact such business as outlined in the notice.

Secretary Mikeska reported that the Special Committee of the Board, consisting of members of the Board's Executive Committee, met on June 22, 2021 to review the minutes of the May 11, 2021 annual meeting, and during the Regular Meeting of the Board of Directors on June 22, 2021, the Special Committee recommended approval of the Annual Meeting Minutes, which were subsequently approved for submission to the Membership at its next annual meeting. Secretary-Treasurer Mikeska requested that Chairman Flencher request a motion to waive reading of the minutes and ratify the Board's approval of the minutes.

Chairman Flencher requested a motion to waive reading of the minutes and ratify the actions of the Special Committee and the Board for approving the minutes of the May 11, 2021, Annual Meeting for submission to the Membership at its next annual meeting.

Motion was made and seconded to waive reading of the minutes and to ratify the actions of the Special Committee and the Board for approving the minutes of the May 11, 2021, Annual Meeting for submission to the Membership at its next annual meeting. The motion carried.

CEO Matt Bentke announced that there is no Unfinished Business or New Business and invited questions from the Directors, to which he responded to their satisfaction.

General Counsel Sarah E. Newman-Altamirano, announced the three incumbent directors nominated for re-election were uncontested and were elected by general consent pursuant to Article II, Section 6 of the Bylaws of the Cooperative:

- Ben Flencher, District 5, Burleson County
- Milton Shaw, District 1, Caldwell, Guadalupe, Gonzales and Hays Counties
- Debbi Goertz, District 3, Bastrop County

There being no further business, Chairman Flencher directed the Board to the drive-through Annual Meeting event and asked for a motion to adjourn at the conclusion of the drive-through event at 3:30 p.m..
